

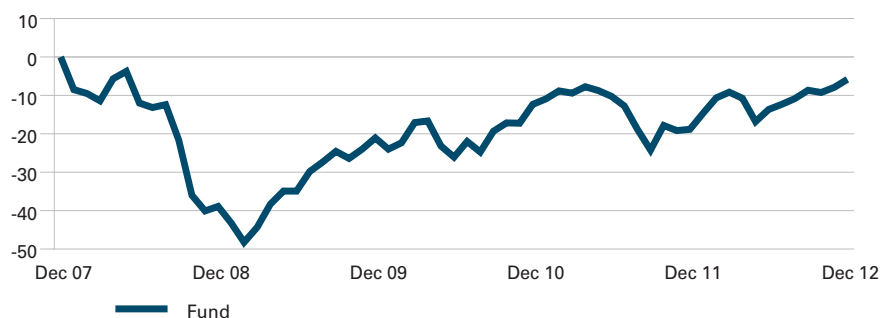

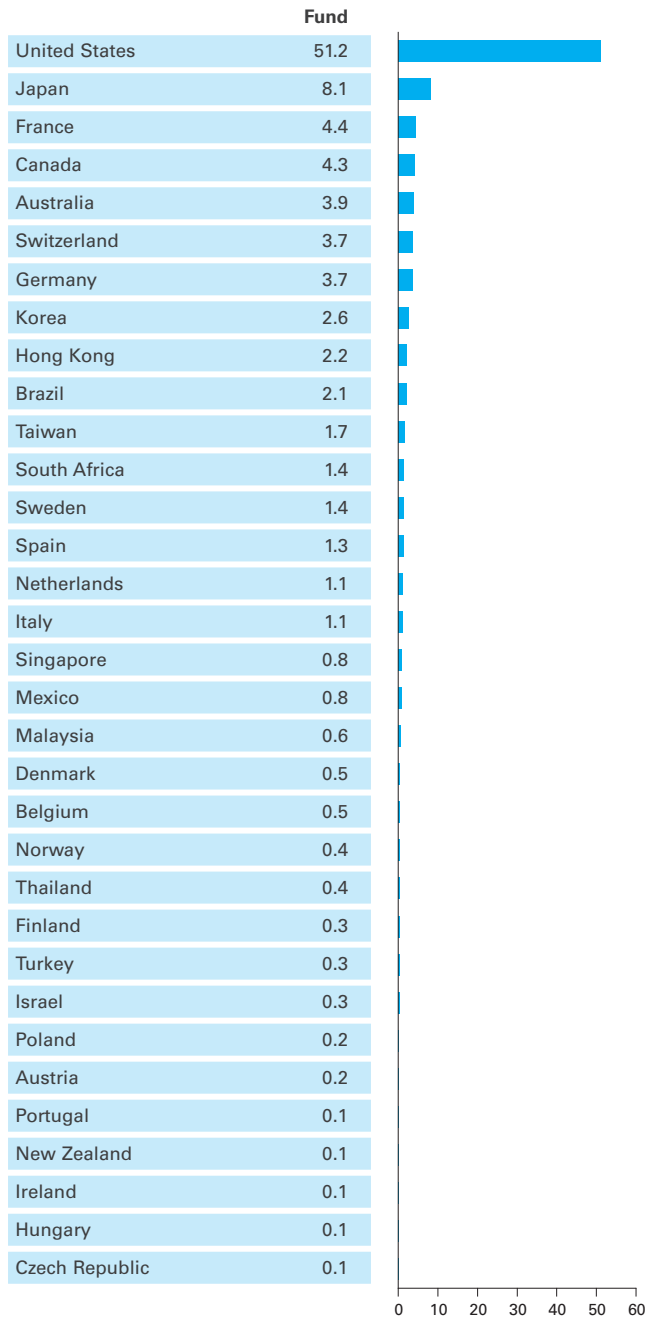
### FUND MANAGER

#### INDEX FUND MANAGEMENT TEAM

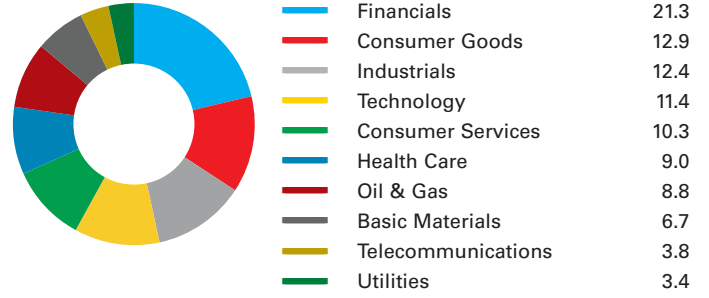

The team of seven Portfolio Managers has an average industry experience of nine years, of which five years has been at LGIM.
